

Year-over-year home prices dropped 5.9% in the second quarter, according to the Federal Housing Finance Agency. Quarter over quarter, the decrease was 0.6%. A rising number of foreclosures are forcing down prices of homes and causing potential buyers to wait for prices to bottom, which reduces demand even further.
